Ngāti Te Whiti is the tangata whenua of Ngāmotu, New Plymouth.

Our rohe extends from the Herekawe to the Waiwhakaiho River, inland to its headwaters on Taranaki and back to the Herekawe.

Ngāti Te Whiti traces descent from our eponymous ancestor – Te Whiti Tuatahi, who lived in the late 1700s. Our right of occupation is based on whakapapa (genealogy) and continuous occupation by generations of connected ancestors from the earliest kinship groups such as Moturoa, Ngāmotu, Ngāti Tuparikino, and Ngāti Tawhirikura.

We have a recorded history of defending this land by exercising our right as tangata whenua as we have maintained our position as ahi kaa or ahi kaa roa – long term occupation. We regard Ngāmotu, New Plymouth, as our tūrangawaewae – our paepae, our footstool, the land on which we alone stand.

4 wananga per 12-month period.
Engage whānau hapū within the hapū that have the knowledge and skills and willingness to share.

Members to receive monthly updates on marae activities.

Ngāti Te Whiti Hapū Board Members to be interim members of the Ngāmotu Marae Reservation as per the Marae Charter.

#### Outcome 12 months

100% of attendees have knowledge of the Tūpuna of Ngāti Te Whiti Hapū. 100% of attendees can recite the Ngāti Te Whiti Pepeha. 100% of attendees have knowledge of waiata, pūrākau, whakatauaki relevant to Ngāti Te Whiti Hapū. 100% of attendees will have knowledge of our sites, including; wāhi tapu, the history and the significance of NgātiTe Whiti Hapū. 50% of attendees can confidently perform, mihi whaikorero karanga. The Ngāmotu Marae build is underway, there will be preliminary hui for new Trustees for the Ngāmotu Marae Reservation.

Continue representation and participation in community forums, and with strategic partnerships.

### Outcome 3 years

Ngāti Te Whiti Hapū members are connected and well informed of the history of our rohe, it's people, and our environment. Te Reo Māori is spoken amongst our members. Ngāti Te Whiti Hapū members can perform the roles of Kaikaranga and Kaikōrero in our Marae. As kaitiaki of our rohē we have established plans that acknowledge and uphold the māna/taiao with Iwi and Tauiwi Regulatory Bodies. Ngāti Te Whiti Hapū contributing to the operational activities of the Marae.

Ngāti Te Whiti has a strong influence in the Ngāmotu/New Plymouth City.
